Senate Committee Passes Bill To Curb The Booting Of Cars In Georgia



An effort to cut back on the practice of booting cars is back on the agenda at the State Capitol. Last year State Senator Josh McLaurin (D-Sandy Springs) introduced a bill to outright ban booting. It never made it to the floor for a vote so this year he is back with HB119 that is more limited in scope.

HB119 would ban property owners or businesses from hiring companies to automatically monitor parking lots. They would be required to call the companies in each instance of an illegally parked car.

The bill would also prohibit a person from paying a property owner for the right to boot or tow a vehicle from that property. Passage of this bill would regulate booting the same way the state regulates towing.

The booting industry's practices were brought back into the spotlight in 2023 when the Boot Girls in Buckhead began advertising their services of using a key to remove a boot from a customer's vehicle for a fee.

What's Next: The bill now moves to the Senate floor for consideration.

State Legislators Prepare For May Primary



With the exception of 16 lawmakers who are retiring, a majority of the 236-member Georgia General Assembly will be running in November.

U.S. Rep. David Scott is facing eight challengers for his 13th Congressional District seat.

U.S. Rep. Lucy McBath, who is running in the newly drawn 6th Congressional District after Republican lawmakers reshaped her current 7th District to favor GOP candidates is running against two democrats and one republican.

Incumbent Rep. Mesha Mainor, R-Atlanta, who switched from the democratic party to the republican party in 2023 is running in the heavily Democratic 56th district. She'll face opposition from four Democratic challengers.

Incumbent Sen. Elena Parent is being challenged by veteran lawmaker Nadine Thomas for the newly formed Senate District 44. The new district was created out of what was District 42 during last year's redistricting session. Thomas served in the Georgia House of Representatives from 1991 to 1993 and became the first Black female to serve in the state Senate (1993 to 2005).

The twenty judges of the Superior Court preside over cases involving misdemeanors, contract disputes, and various other actions. In addition, the Superior Court has exclusive equity jurisdiction over all cases of divorce, title to land, and felonies involving jury trials. Office Of The Sheriff:

The Georgia Constitution mandates that each county has a sheriff, and legislation designates the sheriff as the chief law enforcement officer in the county. In most counties with a sheriff and a county police department, the sheriff voluntarily relinquishes the general law enforcement responsibilities to the county police department, although he cannot be forced to do so.

The sheriff retains the authority to intervene in any law enforcement effort within the county when he felt compelled to do so. This includes actions initiated by deputies of this agency who have witnessed a violation of law or in the absence of a county police officer.

Sheriff's Office Divisions



Jail

Fulton County Jail (FCJ), commanded by the Chief Jailer, has two divisions: Administration and Operations.



Administration

The Administrative Division manages the essential operations of the Fulton County Sheriff's Office including the agency's finances, human resources and background investigations, information technology, planning and research, training, internal affairs, public relations, and fleet sections.



Law Enforcement

The sheriff as the chief law enforcement officer in Fulton County.



Court Services

The Court Services Division is responsible for maintaining the security and integrity of the Fulton County Justice Center Complex, the Juvenile Justice Center (JCC), operating and securing the jail courtrooms, and providing security for the North and South Service Centers.

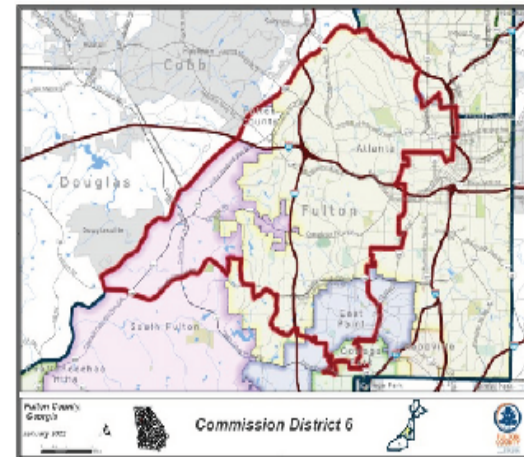

Georgia 2024 Primary Election Dates To Remember

- March 4: This is the first day voters can request an absentee ballot for the Georgia primary election.
- April 22: This is the last day for Georgia residents to register to vote or change their address for Georgia primary election (and for the runoff, if applicable). Registration closes at 11:59 p.m. It is also the day registrars will begin mailing absentee ballots to voters who have requested them.
- April 29: Early voting begins for the Georgia primary election.
- May 10: This is the last day to request an absentee ballot for the Georgia primary election.
- May 17: Early voting ends for the Georgia primary election.
- May 21: Election day for the Georgia primary election. Polls will be open from 7 a.m. to 7 p.m. Mail-in ballots must be received by the time polls close on election day.
- May 24: This is the deadline for provisional voters to present any missing documentation to their county registrar. It is also the deadline for voters to cure ballots with missing signatures or incorrect ID information. All corrections must be completed by 5 p.m.

Dear Residents of Fulton County,

I hope this letter finds you well and in good spirits. My name is Ali Carter, a father of six and a dedicated community servant. I have announced my candidacy for Fulton County Commissioner and for those who may not know me personally, I come from a background rooted in community empowerment and grassroots activism. My journey in service traces back to my time in Chicago with the Chicago Board of Education, where I learned the value of dedication to community affairs long before considering a run for public office.

I understand that some of you may have heard about a challenging chapter in my life, particularly the incident that occurred shortly before Mayor André Dickens's inauguration. I want to address this directly. Yes, I was arrested and escorted off a plane for domestic terroristic threats. This exaggerated claim stemmed from a 2020 warrant that had never been served, originating from my ex-wife regarding a dispute over her then-boyfriend spanking our son. 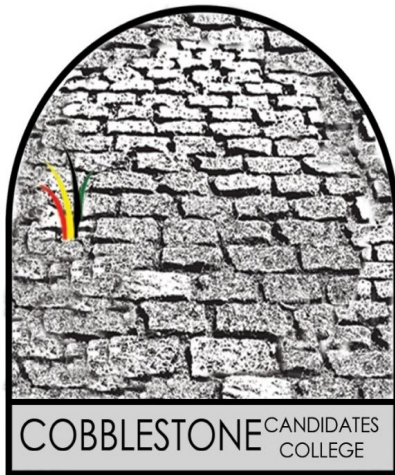

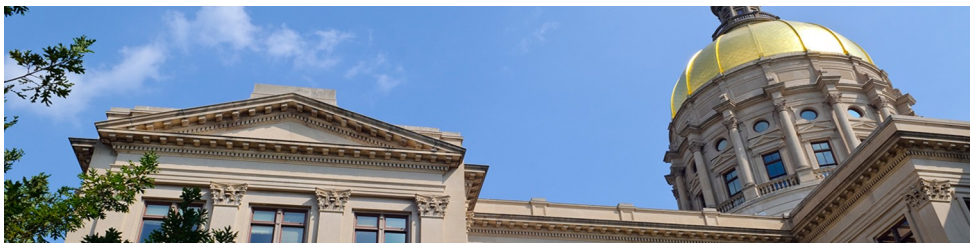
- Senate Bill 189 sets new rules for challenging voters and who can qualify to be placed on Georgia's presidential ballots.

This continuation of voter suppression rules that state lawmakers have instituted over the past few years to dissuade voters and make the election process tougher will take effect in July 2024. Election workers will be further overwhelmed with additional voter eligibility challenges as a result of this bill.

The legislation, which now goes to Gov. Kemp for consideration, includes provisions to remove the secretary of state from the state election board, let any political party that qualifies for the presidential election in at least 20 states or territories be placed on Georgia's presidential ballot, and make it easier for counties to fill vacancies when an elected official prematurely leaves office. The bill also calls for all advance and absentee ballots to be counted within an hour of the polls closing, changes ballot design and creates voting changes for the homeless.

What Didn't Make The Cut....

- SB386 Measures to legalize sports betting
- The review and possible roll back the state's film tax credit, which offers over \$1 billion in tax rebates to production companies each year. The Senate settled on a bill that would require movie producers to film in more Georgia locations, use more local crew and invest more in local studios to earn the credit. But on the last day of session, the film bill was rolled into SB349 which also contains tax credit measures for interactive gaming and affordable housing.



2024 Georgia Legislative Session

It's a wrap... After a marathon session of late-night legislating, the 157th General Assembly worked until the wee hours of the morning passing bills for Gov. Kemp's consideration, thus leaving a plethora of up's and downs.

The up's...

- State employees will get additional \$3,000 raises, including law enforcement officers, corrections officers and child welfare workers.
- The two chambers agreed to provide hundreds of millions of dollars more for Medicaid programs, including \$18.6 million to increase payments to some medical providers, such as obstetricians, optometrists, audiologists and physical therapists.
- Adult dental care was also fully funded with an additional \$10.5 million, and independent pharmacists will see higher reimbursement rates through a new \$6.2 million appropriation.
- Behavioral health got a boost, with \$2.5 million to expand jail-based competency programs, \$26 million for housing voucher slots and \$1 million to expand mental health services in schools.
- A backlog of cases at the Sexual Offender Risk Review Board will be addressed through a \$2.5 million increase
- \$19 million will go to domestic violence shelters and sexual assault centers.
- \$866 million in capital projects for schools systems, colleges, universities and state-funded agencies will be funded with cash rather than bonds, reducing future debt obligations.
